



The Steam Team Expands Mold Remediation Services Across Multiple Texas Cities

The development reflects a response to increased demand for professional inspection, containment, and removal of mold-related damage across residential and commercial properties in the region.

Founded in 1983 and headquartered at 9901 Burnet Road, The Steam Team has built its reputation on water damage restoration, fire damage recovery, and emergency response services. Over the past four decades, the company has served tens of thousands of property owners, often working in coordination with insurance adjusters and property managers to restore buildings following environmental damage.

The introduction of mold remediation services into these additional service areas comes at a time when

property owners are facing growing concerns related to indoor air quality and moisture-related structural issues. Mold growth is often linked to water intrusion events such as flooding, plumbing leaks, and humidity buildup, conditions that are not uncommon in Central Texas due to seasonal storms and rapid development patterns. Industry data suggests that mold can begin developing within 24 to 48 hours after water exposure, increasing the urgency for timely intervention.

The Steam Team's expansion aims to provide a structured and compliant remediation process to communities that have experienced population growth and increased construction activity in recent years. Round Rock, Manor, and Cedar Park have all seen continued residential and commercial development, contributing to a higher volume of restoration needs tied to both new construction and aging infrastructure.

David Marquardt, owner of The Steam Team, stated that the decision to expand was driven by both operational capacity and regional demand. "Expanding mold remediation services into these communities allows the company to respond more effectively to property damage scenarios that require specialized containment and removal procedures," said David Marquardt. "The goal is to ensure that property owners have access to licensed professionals who understand the regulatory requirements and technical processes involved in mold remediation."

Mold remediation differs from general cleaning or maintenance services due to its regulatory and procedural requirements. In Texas, remediation work must follow strict guidelines set by the Texas Department of Licensing and Regulation. This includes the use of containment barriers, negative air pressure systems, and approved antimicrobial treatments. The Steam Team operates under a state-issued mold remediation contractor license and follows established protocols designed to prevent cross-contamination and ensure safe removal practices.

The company's remediation process typically begins with a detailed inspection and moisture mapping assessment. This step identifies the source of water intrusion and evaluates the extent of contamination. Once the affected areas are identified, technicians implement containment measures to isolate the impacted zones. High-efficiency particulate air filtration systems are then used to capture airborne contaminants while the removal of affected materials is carried out.

Following removal, surfaces are treated with antimicrobial agents, and structural drying equipment is deployed to eliminate residual moisture. This process often involves the use of dehumidifiers, air movers, and moisture meters to monitor drying progress. Once moisture levels are stabilized, reconstruction or repair work may be initiated if structural elements have been compromised.

The Steam Team's integrated approach allows coordination between mold remediation and other restoration services such as water damage mitigation and structural drying. This continuity is intended to reduce delays

and streamline recovery efforts for property owners managing insurance claims or business interruptions.

Local officials and property managers in expanding service areas have noted the importance of access to certified restoration contractors, particularly as commercial development continues to increase. Facilities such as office buildings, retail centers, and multi-unit housing complexes often require rapid response to environmental hazards to maintain occupancy and compliance standards.
